NOTICE is hereby given that West Sussex County Council, under the provisions of the Highways Act 1980 (Traffic calming) Regulations intends to install two raised traffic calming features on Ringmer Road in Worthing.

The first road hump feature would be installed on Ringmer Road 7m north of its junction with Terringes Avenue. This feature would be a total of 5.5m in length.

The second road hump would be installed on Ringmer Road 7m south of its junction with Terringes Avenue. This feature would be a total of 8m in length.

Both of the proposed features would be constructed from black macadam and would be 65mm in height. The ramps for each feature would be 65cm long for the first feature and 96cm long for the second feature.

NOTICE is also given that it is also proposed to make a permanent Order under the Road Traffic Regulation Act 1984, the effect of which will be to extend the existing double yellow lines on Ringmer Road, south of its junction with Terringes Avenue, southwards by 2m to meet the new traffic calming feature proposed at this location.

Statement Of Reasons For Proposing To Install Traffic Calming

West Sussex County Council proposes to install raised traffic calming features on Ringmer Road in Worthing.

The first road hump feature would be installed on Ringmer Road 7m north of its junction with Terringes Avenue. This feature would be a total of 5.5m in length.

The second road hump would be installed on Ringmer Road 7m south of its junction with Terringes Avenue. This feature would be a total of 8m in length.

Both of the proposed features would be constructed from black macadam and would be 65mm in height. The ramps for each feature would be 65cm long for the first feature and 96cm long for the second feature.

The proposed features are proposed to improve safety at the crossroads formed by Ringmer Road and Terringes Avenue, at which traffic on Ringmer Road must give way to traffic on Terringes Avenue. The features will reduce traffic speed on the approaches to Terringes Avenue and highlight the presence of the junction.

It is also proposed to extend the existing double yellow lines on both sides of Ringmer Road, south of its junction with Terringes Avenue, southwards by a distance of 2m to meet the proposed new traffic calming feature at this location. This is proposed to stop vehicles parking close to the new feature and obstructing visibility for approaching traffic and pedestrians crossing the road at this location.

The proposed traffic calming measures and amended parking restrictions are proposed to prevent danger to persons or traffic using the effected length of road.

The attached drawing, numbered 435167-WSCC-100-1 shows the layout of the proposed traffic calming features. Drawing number TQ1204SWS shows the proposed amendment to the waiting restrictions.

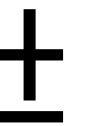
