**NOTICE** is hereby given that West Sussex County Council proposes to introduce a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce a 30mph speed limit on Red Lane and lengths of School Lane and, a 20mph speed limit on School Lane in the vicinity of Shipley CE Primary School.

**Statement Of Reasons For Proposing To Make The Order**

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to introduce a 30mph speed limit on Red Lane and lengths of School Lane and, a 20mph speed limit on School Lane in the vicinity of Shipley CE Primary School

School Lane/Red Lane runs between Pound Lane and Smithers Hill Lane and is a D class derestricted road. The road has no footways and a high volume of vulnerable road users partly as it is the address of Shipley CE Primary School. The school made a formal request for the speed limit to be reduced.

This road is a route well used by cyclists, walkers with dogs and horses as well as school children. A review of the speed limit has been carried out and the proposed 30mph speed limit, with a 20mph speed limit in close proximity to the school, is compliant with the County Council's Policy and more adequately reflects the character and users of the road. The primary aim of the initiative is of road safety and casualty prevention, and it is intended that this approach will not compromise the effectiveness of existing speed limits around the County.

This Order is proposed so as to avoid danger to persons or other traffic using the road or to minimise the likelihood of any such danger arising, for facilitating the safe passage on the road of any class of traffic, for preventing damage to the road, for preserving or improving the amenities of the area through which the road runs and for preserving the character of the road in a case where it is especially suitable for use by persons on horseback or on foot..

Drawing Shipley: Proposed 20mph and 30mph Speed Limits (28.02.23) shows the length of road, which is the subject of the proposed Order.

**WEST SUSSEX COUNTY COUNCIL**

**(20MPH & 30MPH SPEED LIMIT) ORDER 2023**

West Sussex County Council in exercise of their powers under Sections 82 and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the x day of x 2023 and may be cited as "West Sussex County Council (Shipley: School Lane & Red Lane) (20mph & 30mph Speed Limit) Order 2023"
2. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour in the length of road specified in the First Schedule to this Order.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of road specified in the Second Schedule to this Order.
4. Nothing in Paragraphs 2 and 3 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown on an occasion when –
  - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
  - (b) the vehicle is being driven-
    - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
    - (ii) for the purpose of training a person in driving vehicles at high speeds.

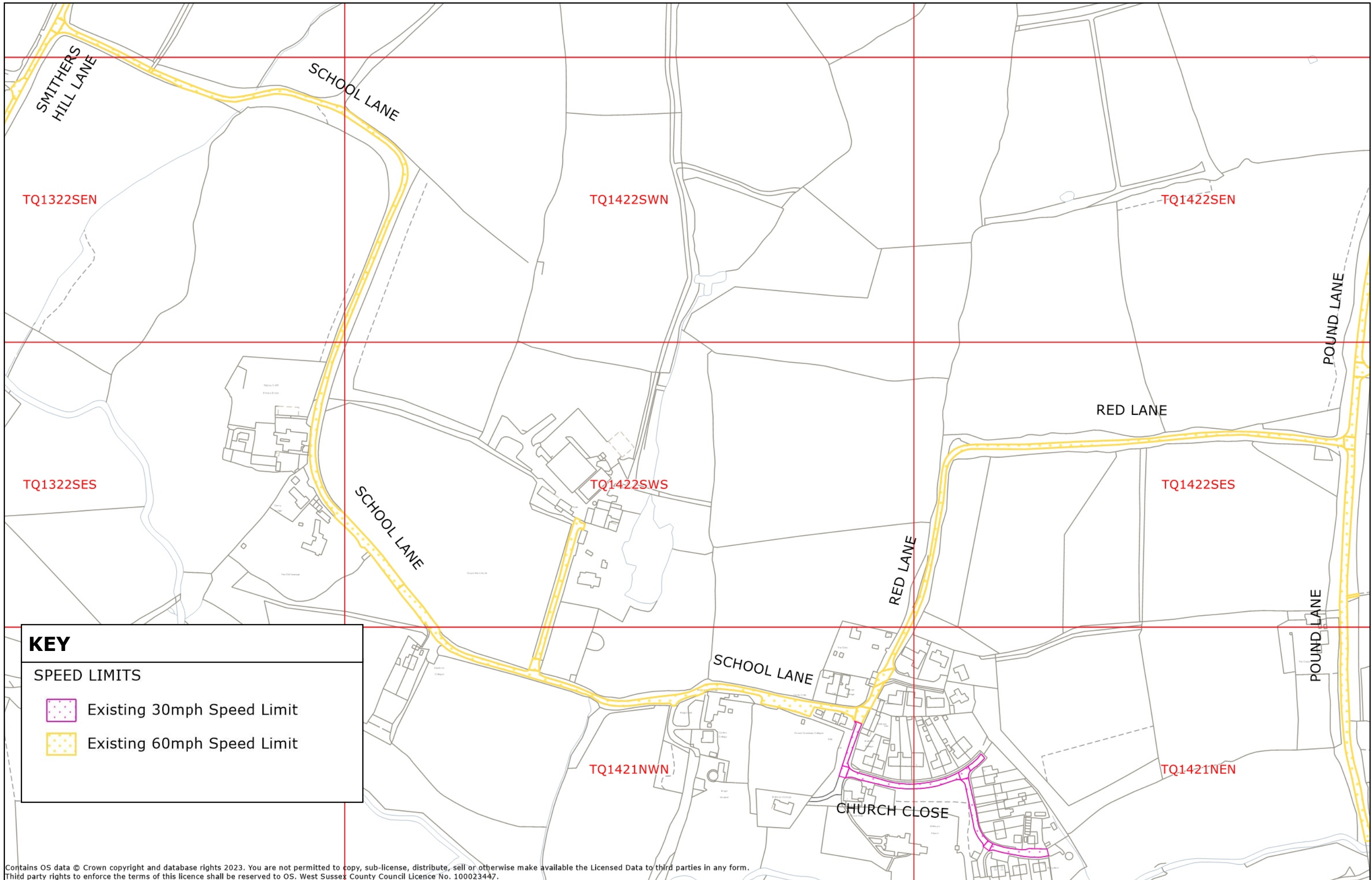

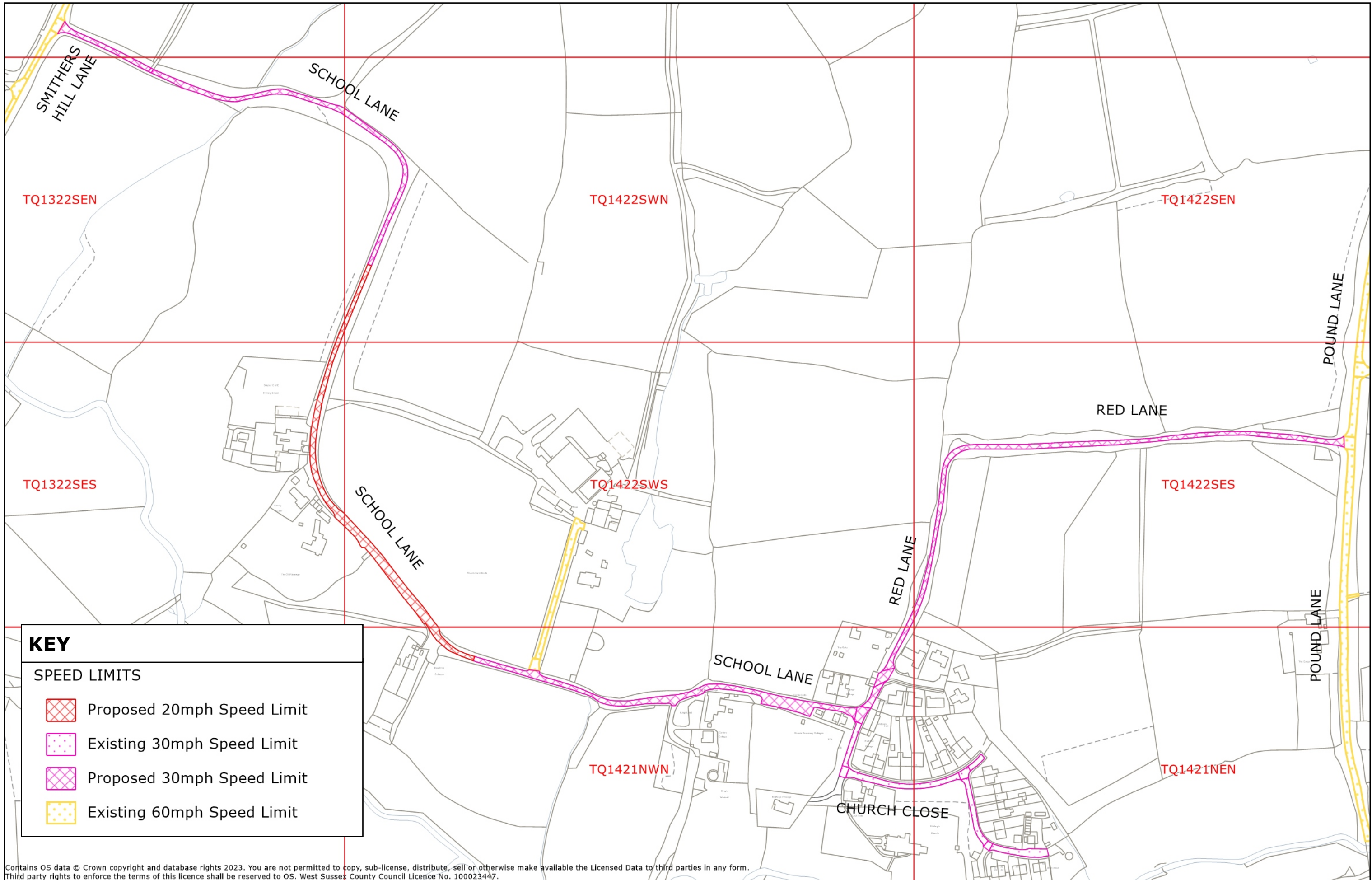
