NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) on St Valerie Road in Worthing at its junctions with Bath Road, Hythe Road and Boundary Road. The Order would also prohibit waiting at any time at the junction of Downview Road with Boundary Road.

**Statement of Reasons for Proposing to Make the Order**

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce double yellow lines on St Valerie Road in Worthing at its junctions with Bath Road, Hythe Road and Boundary Road. The Order would also prohibit waiting at any time at the junction of Downview Road with Boundary Road.

The council has received a community led application for a Traffic Regulation Order to control parking at the junctions of St Valerie Road and Downview Road. The application raised concerns that vehicles are frequently parked too close to these junctions, obstructing visibility for road traffic and pedestrians. When the application was assessed, council highway officers agreed that restrictions at these junctions would improve safety.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawings, numbered TQ1302SEN, TQ1302SES, TQ1302SWN and TQ1302SWS show the lengths of roads affected by the proposed order.

West Sussex County Council in exercise of their powers under Sections 1 (a) 2 (1) and (2), 4 (2), 45. 46. 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-
